### **SUMMARY**

The Library is requesting Board's approval approve a grant agreement from the Governor's Office of Economic Development (GOED) and the Economic Development Authority of Western Nevada (EDAWN) in the amount of up to \$15,000 (GOED \$10,000, EDAWN \$5,000), with up to \$7,300 local match required (in-kind), for a term from July 15, 2015-June 30, 2016, in support of Carson City Library's "Nevada's Working Capital" Project, direct the Comptroller's Office to make the necessary budget adjustments and authorize the Director to sign the grant award documents.

County Priority/Goal supported by this item: Sustainability, including financial sustainability, sustaining our services and infrastructure, and sustainability of our natural resources.

#### **PREVIOUS ACTION**

None.

#### **BACKGROUND**

The Library received an award notification for an EDAWN grant in the amount of \$15,000. If accepted, the grant will be used to expand Manufacturing Technician Level 1 (MT-1) training into Reno by building upon the existing Carson City Library's "Nevada's Working Capital" project. Washoe County Library staff will be trained and certified as MT-1 instructors and will be able to train up to 20 individuals in the MT-1 curriculum,

enabling them to receive certificates and pass the related exam. There would be two offerings of the course: Fall 2015 and Spring 2016 with up to 10 students in each session.

Additionally, the funding provides access to the curriculum for the public to use computers or in-house Wi-Fi for individual studying. Washoe County Library System would obtain certification as a Manufacturing Skills Institute (MSI) Assessment Center, enabling one or more branches to serve in this capacity to administer the MT-1 Exam to those who have either completed the instructor-led course or else prepared themselves via the online material.

The Nevada Governor's Office of Economic Development (GOED) and The Economic Development Authority of Western Nevada (EDAWN) have approved a combined grant in the amount of up to \$15,000 (GOED \$10,000, EDAWN \$5,000) for support of MT-1 training classes. The grant period will be for a time period of July 15, 2015 – June 30, 2016. This grant is a partnership with GOED and EDAWN to support the Washoe County Library System. #### Report content:

- Number of individuals trained in the MT-1 curriculum;
- Number of individuals receiving certificates;
- Number of individuals that pass the related MT-1 exam;
- Number of MT-1 course offerings and schedule;
- Number of students in each MT-1 course session;
- Number of library public-use computers or description of in-house Wi-Fi, to offer online MT-1 curriculum for individuals wishing to study on their own; and
- Proof of certification as an MSI Assessment Center, and number of branches to serve in that capacity to administer the MT-1 Exam to those who have either completed the instructor-led course or else prepared themselves via the online material.

#### EXHIBIT B GRANT REQUEST

#### PROJECT DESCRIPTION

The Washoe County Library System (WCLS) wishes to support and supplement Carson City Library's "Nevada Working Capital" project (a Library Services and Technology Act grant-funded initiative), by engaging in the following activities:

- Obtain training for two WCLS employees to become certified instructors of the Manufacturing Technician Level 1 (MT-1) curriculum
- WCLS instructors train up to 20 individuals in the MT-1 curriculum, enabling them to receive certificates
  and pass the related exam. There would be two offerings of the course, one in Fall 2015 and one in Spring
  2016, with up to 10 students in each session.
- Offer access, via library public-use computers or in-house Wi-Fi, to the online MT-1 curriculum for individuals wishing to study on their own
- Obtain certification as an MSI Assessment Center, enabling one or more branches to serve in that capacity
  and administer the MT-1 Exam to those who have either completed the instructor-led course or else
  prepared themselves via the online material

#### **DELIVERABLES**

- Two WCLS employees certified for three years as MT-1 course instructors
- By June 2016: Up to 20 individuals who complete the instructor-guided MT-1 course and pass the required competency exam at a WCLS Assessment Center location
- By June 2016: Five (5) individuals who study the MT-1 curriculum online via WCLS computers or Wi-Fi, and as a result are able to pass the requisite exam at a WCLS Assessment Center location
- Similar deliverables in the succeeding two years (July 2016-June 2017 and July 2017-June 2018); may be adjusted based on experience in the first year

#### **OUTCOMES**

- Up to 25 individuals pass the MT-1 exam and improve their qualifications for advanced manufacturing technician jobs
- Of those, 10 individuals or 40%, whichever is higher, are able to obtain an MT-1 position, either as a new hire or through promotion at their current employer, within one year of passing the MT-1 exam.
