SUBJECT: Approve, on the recommendation of the Chair and the Chair of the District Board of Health Trustees, the appointment to the Washoe County District Board of Health from a pool of applicants including; Kathleen Banich-Bates, Matthew Buehler, Chelsea Hart, Joseph Herman, Bruce Judd, Dr. Michael Kinnison, Dr. Christopher Mumm, Toya Norton, Dr. John Packham, Dr. Troy Ross, Brian Sooudi, and Tom Young, [recommend Tom Young] as the Washoe County Commission's non-elected member to fill a remaining term through December 31, 2020 (All Commission Districts).

SUMMARY

The District Board of Health (DBOH) is a policy-making board composed of seven members, which includes two (2) representatives each from Reno, Sparks and Washoe County, in addition to a physician licensed to practice medicine in Nevada. The District Board of Health, through the Washoe County Health District, has jurisdiction over all public health matters in the Health District. Member of the District Board of Health serve four year terms. Each member may be re-appointed in the same manner as their original appointment to serve not more than two (2) additional terms.

David Silverman had completed his first term on the District Board of Health and was reappointed for a second term through December 31, 2020. Mr. Silverman tendered his resignation in January 2017 which created a vacancy on the Board.

The DBOH Chair Jung expressed her interest in having individuals from the food service industry apply for the Board vacancy to be considered for appointment to replace Mr. Silverman, who is a restaurant owner and has extensive experience in the Industry.

PREVIOUS ACTION

December 13, 2017 - Washoe County Commissioners reappointed David Silverman to the Washoe County District Board of Health as the Commission's non-elected member for the term commencing on the date of appointment through December 31, 2016.

October 8, 2013 – Washoe County Commissioners appointed David Silverman to the Washoe County District Board of Health as the Commission's non-elected member for the term commencing on the date of appointment through December 31, 2016.

December 16, 2008 – Washoe County Commissioners reappointed George J. Furman, MD to the Washoe County District Board of Health as the Commission's non-elected member for a a four year term serving from December 31, 2008 through December 31, 2012.

BACKGROUND

Per the 1993 Amendment to the Interlocal Agreement concerning the Washoe County Health District, Section 2, Subsection D Article III, Section IV of the District Board of Health by-laws, it is necessary for the Board of County Commission to approve the appointment of a non-elected Washoe County representative to the District Board of Health. Members of the District Board of Health serve four year terms. Each member may be reappointed in the same manner as their original appointment to serve not more than two additional terms.

The District Board of Health board position has been advertised as a volunteer opportunity for several months on the Washoe County website. Twelve (12) applicants (attached) applied for consideration. They include:

Staff recommends that Mr. Tom Young be appointed as the Washoe County non-elected representative on the District Board of Health. Mr. Young is an owner of Great Basing Brewing Company and has extensive experience in the food service industry. Food service establishments are the largest sector regulated by the Health District and his experience will provide valuable diversity and perspective for the District Board of Health.

FISCAL IMPACT

There is no fiscal impact associated with Washoe County's making appointments to or participating on the District Board of Health of Trustees.
