He advised that language added as the last sentence of that article states that "The effective date shall be the date upon which the signatory to be charged by the subject modification approves the modification."

Chairman Galloway commented that yesterday's meeting was very good; and that he would request that staff look into the matter of training issues which were raised at that meeting with the point of view of some sort of general consistency from one GID to another depending on size.
