# 07-27SF <u>AWARD OF BID - TWO TYPE ONE FIRE APPARATUS - BID NO.</u> 2958-07

This was the time set to consider award of the bid for two Type One Fire Apparatus.

Chief Michael Green clarified the bid was based on specifications.

One Bid was received from Pierce Mfg., Inc.

Upon recommendation of Mike Burdett, Buyer, on motion by Commissioner Humke, seconded by Commissioner Sferrazza, which motion duly carried with Chairman Larkin absent, Vice Chairman Weber ordered that Bid No. 2958-07 for two Type One Fire Apparatus, on behalf of the Districtbe awarded to Pierce Mfg., Inc., the sole responding bidder, in the amount of \$779,190. It was noted that one apparatus would be purchased out of the FY 2006/07 budget, in the amount of \$389,595, and one apparatus would be purchased out of the FY 2007/08 budget, in the amount of \$389,595.
