He said the auditor's opinion of the financial statements were an unqualified opinion, meaning the financial statements present fairly, in all material respects, the respective financial position of the District's governmental activities. Chief Greene stated the auditors found the District conformed to all significant statutory constraints on its financial administration during the year and that there were no material weaknesses of a magnitude to justify inclusion within the report. He said there were no audit recommendations made in the audit report for fiscal year 2008/09. Chief Greene remarked it was recommended that the Board of Fire Commissioners accept the District's Audited Financial Statements for fiscal year 2008/09.
