Agenda Subject: "Authorize the Chairman to execute Employment Agreement between the Sierra Fire Protection District, Battalion Chief Timothy Leighton, and the Sierra Fire Protection District Chief Officers Association for employment of Leighton as Acting Fire Chief retroactive to November 8, 2011. (All Commission Districts.)"

Kurt Latipow, Fire Services Coordinator, said direction was given that upon Chief Greene's departure and Battalion Chief Tim Leighton being made Acting Chief, the Chairman was authorized to negotiate an agreement with Chief Leighton. He noted the agreement was ready for formal action.

Chairman Breternitz commented the basic agreement was reached after the November Board meeting and he believed it was a fair arrangement.

There was no public comment on this item.

On motion by Commissioner Larkin, seconded by Commissioner Weber, which motion duly carried with Commissioner Humke absent, it was ordered that Agenda Item 4 be authorized and executed.

Agenda Subject: "Chief's Report including Arrowcreek Station."

Acting Chief Leighton stated since the last meeting there had been five significant incidents within the District. There were three structure fires, the multi-jurisdictional Caughlin fire, and a wildland fire in Little Valley. He reported there were no civilian injuries and one firefighter injury. He explained the process for the fire and rescue efforts during the fire in Little Valley and echoed the sentiments of Chief Hernandez for the Caughlin fire. He stated the Arrowcreek station was on time and on budget.

There was no action taken or public comment on this item.

11-160SF <u>AGENDA ITEM 6</u>

Agenda Subject: "Review and acceptance of the Sierra Fire Protection District's Audited Financial Statements for the Fiscal Year Ended June 30, 2011."

Felicia O'Carroll, Kafoury, Armstrong & Company, stated the Sierra Fire Protection District (SFPD) received an unqualified opinion, which was a clean opinion and not subject to any qualifications. She stated page 18 (note 2) indicated they did not run across any potential Nevada Revised Statutes or Nevada Administrative Code violations. She reported there was one finding that related to payroll, which was a repeat of the finding from last year. She explained the SFPD's payroll cycle showed no evidence of appropriate review or approval of certain transactions. She stated those procedures were changed in June and she did not expect it to be a repeat finding next year.

There was no public comment on this item.

On motion by Commissioner Larkin, seconded by Commissioner Jung, which motion duly carried with Commissioner Humke absent, it was ordered that Agenda Item 6 be accepted.

Agenda Subject: "Recommendation to approve Offer and Acceptance Agreement to sell the original Arrowcreek fire station parcel (donated/deed restricted parcel of land APN 152-921-02) to Zephyr Capital, LLC or nominee, and split the net proceeds with the parcel donor, Arrowcreek developer Southwest Pointe Associates per agreement, resulting in approximately \$32,789 revenue to the Sierra Fire Protection District, and if approved, authorize the Chairman to execute upon presentation all closing documents, deeds, warrants, and checks, as needed to facilitate the closing and transfer. (Commission District 2.)"
