<u>10:15 a.m.</u> This was the time set in a Notice of Public Hearing published in the Reno Gazette-Journal on May 11, 2001 to provide for public comment in the consideration of the South Truckee Meadows General Improvement District Tentative Budget for Fiscal Year 2001/2002, as well as possible adoption of the Final Budget. Proof was made that due and legal Notice had been given.

Jeff Tissier, Accounting Manager, Department of Water Resources, reviewed the 2001/2002 budget. He advised that STMGID is a well-funded utility and is able to fully fund all repair and replacement projects from operating cash flow; the ad valorem tax rate is expected to be about 0.1216, which is a decrease from last year's

0.1329 rate; and the budget reflects the new rates adopted by the Board of Trustees in January, as well as the impact of the Hay Study. Mr. Tissier responded to questions of Commissioner Short.
