## 04-17STM APPROVAL OF BUDGET – FISCAL YEAR 2004/05

**1:30 p.m.** This was the time set in a Notice of Public Hearing published in the *Reno Gazette-Journal* on May 7, 2004 to consider the tentative and final budget for fiscal year 2004/05 for the South Truckee Meadows General Improvement District (STMGID). Proof was made that due and legal Notice had been given.

Chairman Shaw opened the public hearing by calling on anyone wishing to speak for or against the approval for STMGID budget. There being no response the Chairman closed the public hearing.

Jerry McKnight, Water Resources, explained the STMGID budget for 2004/05, as outlined in the report to the State of Nevada Department of Taxation dated May 7, 2004. He pointed out that this is the first year STMGID has filed a budget since
