PUBLIC COMMENTS

Gary Schmidt commented that he was pleased to see such a large crowd for the public hearing to discuss the South Valleys Area Plan.

BOARD, LOCAL MANAGING BOARD AND STAFF COMMENTS

Steve Cohen, Chairman of the Local Managing Board, indicated the filter media for Well No. 9 was not allowing the well to pump as efficiently as it should and would cost about five or six times the normal rate. He stated the well was in place, was paid for, and was expected to be pumping through October before an alternate source would be required. Mr. Cohen commented that the State Engineer had asked for some permits on Well No. 12 before allowing the District to go ahead with the test well, possibly delaying bids by two to three weeks. After ongoing work for about a year now, he indicated the quitclaims to transfer title from the County to the South Truckee Meadows General Improvement District would be on next month's Board agenda.

Commissioner Galloway asked if there was still a possibility that water from Well No. 9 could be blended with stream water once the new treatment plant was operational. Mr. Cohen stated it was his understanding there would be no need for the special arsenic filters to run water through the treatment plant. He clarified that Well No. 9 would still be useful for conjunctive use.
