In accordance with the Open Meeting Law, on motion by Trustee Weber, seconded by Trustee Humke, which motion duly carried, Chairman Larkin ordered that the agenda for the September 18, 2007 special meeting be approved.

07-41STM AGENDA ITEM 3 - INTRODUCTION OF ORDINANCE

Agenda Subject: "Approve the ordinance amending the powers of the LMB by delegating additional powers to the LMB; and direct staff to bring the ordinance to the Board of County Commissioners for introduction and first reading, and to set the date for a second reading and public hearing of the amendment."

In response to Commissioner Galloway, Rosemary Menard, Water Resources Director, explained during the term of the Interim Western Regional Water Commission, the amendment would provide the Local Managing Board (LMB) the authority to appoint one of their members to sit on that Board and represent the District.

Commissioner Galloway asked if the Board of Trustees would have the ability to direct subsequent amendments and had there been a legal opinion as to whether the LMB could be converted to the Board of Trustees of the District. Ms. Menard replied that agenda item was scheduled for the October 23, 2007 District meeting. She indicated the provisions in NRS 318 did not provide the opportunity for a switch to have the LMB be their own Trustees. She said the requirement was the Board of Trustees would dissolve the General Improvement District (GID) so that the GID would have the

opportunity to reform themselves. She said; however, in order to proceed, the GID would need permission from the Reno City Council.

Upon recommendation of Ms. Menard, on motion by Trustee Humke, seconded by Trustee Weber, which motion duly carried, Chairman Larkin ordered that the ordinance amending the powers of the LMB by delegating additional powers to the LMB be approved. It was further ordered that staff be directed to bring the ordinance to the Board of County Commissioners for introduction and first reading and to set a date for a second reading, public hearing, and adoption.
