The Trustees will also hear public comment during individual action items, with comment limited to two minutes per person. Comments are to be made to the Trustees as a whole."

There was no response to the call for public comment.

08-20STM AGENDA ITEM 3

Agenda Subject: "Approve and authorize the Chairman to execute the Interlocal Agreement for Operation and Maintenance of Water Facilities between Washoe County and the South Truckee Meadows General Improvement District."

Commissioner Galloway related a comment by Steve Cohen, Chairman of the Local Managing Board (LMB), that rates were growing to the point where it would be necessary to look at other providers. He wondered if anything could be done to reduce costs and charges. Ted Rolfs, Fiscal Compliance Officer, said the Department of Water Resources recently entered into an agreement to install towers that would read meters, with an estimated savings of \$60,000 to \$70,000 per year. He explained the dollars had been left in the 2008-09 budget because it was uncertain when the equipment would be ready. He indicated the equipment was now on order and installation was expected

around July 1, 2008. He stated there was discussion at the LMB level to undertake a rate study at the end of the fiscal year. The study would take a comprehensive look at items such as power consumption, well production and resource utilization. For example, if excess storage capacity were put in, it might be possible to improve efficiencies by pumping during off-peak times.

Commissioner Galloway asked whether there were better electrical rates for off-peak usage. Mr. Rolfs replied there were various rate schedules for different pumping facilities. Commissioner Galloway hoped the review would determine whether it was possible to qualify for better rate schedules. Mr. Rolfs said they would also be looking at using variable speed pumps to reduce the load and demand on the system.

There was no public comment on this item.

On motion by Trustee Humke, seconded by Trustee Weber, which motion duly carried, it was ordered that Agenda Item 3 be approved, authorized and executed.
