Agenda Subject: Recommendation to award a bid to RDC, Inc., the lowest responsive, responsible bidder, in the amount of \$115,300 to convert the arsenic removal system for STMGID Well 9; and if awarded authorize the Chairman to execute the Agreement Form and authorize the Acting Engineering Manager to issue the Notice to Proceed.

In response to Trustee Jung, Rick Warner, Acting Engineering Manager, replied one bid was received.

Chairman Larkin asked if a staff member had physically gone to RDC Inc., to verify that this company existed.

Chairman Larkin said for the foreseeable future the Board of Trustees would need safeguards and Trustee Galloway added verification that the contractor was a qualified contractor with the ability to perform.

Mr. Smiley indicated he had been to RDC Inc., on several occasions fact-finding for previous projects. He explained he was not the originator of the request to award the bid

Trustee Galloway commented there was a year-to-date summary of water coming in and out of the South Truckee Meadows General Improvement District (STMGID) and asked if that was a calendar year or a fiscal year. Rick Warner, Acting Engineering Manager, replied that was not noted properly, but believed it was a fiscal year.

Trustee Galloway asked if this would be "settled up" at the end of the fiscal year between Washoe County and STMGID. In review, he noted Washoe County would owe money to STMGID. Rosemary Menard, Water Resources Director, explained the water accounting was conducted on a calendar year basis. She said at the end of 2007 STMGID owed Washoe County water and had six months to pay that water back. Ms. Menard indicated the "settling up" would occur at that point; however, she would review the process and return to the Board with a better explanation. Trustee Galloway asked if STMGID would get credit against their water deficit from the 29 million gallons in the calendar year. Ms. Menard believed that was how it would be completed.

There was no action taken on this item.

A RESOLUTION APPROVING THE AMENDED AND RESTATED JOINT POWERS AGREEMENT AMONG THE CITY OF RENO, CITY OF SPARKS, SOUTH TRUCKEE MEADOWS GENERAL IMPROVEMENT DISTRICT, SUN VALLEY GENERAL IMPROVEMENT DISTRICT, TRUCKEE MEADOWS WATER AUTHORITY AND WASHOE COUNTY CREATING THE WESTERN REGIONAL WATER COMMISSION AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, Senate Bill 487, codified as the Western Regional Water Commission Act, Chapter 531, Statues of Nevada 2007 (Special Acts), establishes the Western Regional Water Commission to be effective on April 1, 2008; and

WHEREAS, Section 24 of Senate Bill 487, codified as the Western Regional Water Commission Act, Chapter 531, Statues of Nevada 2007 (the "Act"), provides that by entering into a cooperative agreement pursuant to NRS 277.080 to 277.180, inclusive, the City of Reno, City of Sparks, Washoe County, Sun Valley General Improvement District, South Truckee Meadows General Improvement District and Truckee Meadows Water Authority may jointly authorize the Regional Water Commission to exercise such powers, privileges or authority that each of those entities may individually exercise pursuant to the laws of this State; and

WHEREAS, the Amended and Restated Joint Powers Agreement is to implement Section 24 of the Act; and

WHEREAS, the South Truckee Meadows General Improvement District is authorized to enter into a joint powers agreement for the performance of any governmental function pursuant to the provisions of NRS 277.080 to 277.180; and

WHEREAS, on January 22, 2008, the South Truckee Meadows General Improvement District Board of Trustees approved the Joint Powers Agreement; and

WHEREAS, on May 16, 2008, the Western Regional Water Commission approved the action to amend and restate the Joint Powers Agreement; and

WHEREAS, the South Truckee Meadows General Improvement District Board of Trustees desires to approve the Amended and Restated Joint Powers Agreement; and
