The Board convened at 12:38 p.m. in regular session in the Commission Chambers of the Washoe County Administration Complex, 1001 East Ninth Street, Reno, Nevada, and conducted the following business:

<u>Agenda Subject</u>: "Public Comment. Comment heard under this item will be limited to two minutes per person and may pertain to matters both on and off the STMGID Board of Trustees agenda. The Trustees will also hear public comment during individual action items, with comment limited to two minutes per person. Comments are to be made to the Trustees as a whole."

Ed Griffith spoke about illegal dumping. He objected to the Waste Management contract that extended through the year 2020 and asked the Commission to work with them on lowering their rates. He stated the Golden Valley Property Owners Association (POA) had a water recharge program and was looking into buying water rights rather than leasing them from STMGID. He asked the Board members to help in any way possible so that the rights could be obtained at a reasonable cost. He noted the lease with STMGID was coming up for renewal, which included an annual 3 percent increase. He hoped the Commission would not grant the increase unless it was justified.

Roger Edwards said he had been on the Board of the Golden Valley POA when the water leases were first negotiated with the University. He thanked the Department of Water Resources for their assistance and thanked STMGID for coming through with leases when the University was going to drastically increase its prices. He explained the POA wanted to lower the amount of water it leased to 120 acre feet and save fees toward the purchase of water rights that would secure Golden Valley's future.

Dwayne Smith, Acting Senior Licensed Engineer, said he was working with the LMB to develop programs such as asset management programs, as part of the continuing process to maintain the level of service STMGID customers had come to expect. He indicated he would be bringing additional agenda items to the Board during the first part of 2010.
