She stated historically the LMB offered more generous provisions than the recommendations by the Well Mitigation Hearing Board. She said after DWR made an offer, Mr. Scheetz came in and staff reviewed the conditions and made an additional offer, which Mr. Scheetz was still not happy with. She said Mr. Scheetz was provided with some additional information and he was going to do some research and get back to staff, which she did not believe happened.

Chairman Humke said Mr. Scheetz's request was to continue this item, and he believed the research was continuing.
