The Board met pursuant to a recess taken Friday, February 11th, 1916, and transacted the following business, to-wit:-

RELIEF GRANTED.

W. H. H. Scott was granted relief in the sum of \$10.00 to be paid for the months of February and March only.

ORDINANCE FOR THE PROTECTION OF ELK.

The District Attorney presented the following ordinance relating to the protection of Elk.

"AN ORDINANCE TO PREVENT THE KILLING, CATCHING, TRAPPING, HUNTING OR PURSUING WITH AN INTENT TO CATCH, CAPTURE, INJURE OR DESTROY ANY ELK IN THE COUNTY OF WASHOE, STATE OF NEVADA, BEFORE THE FIRST DAY OF MAY, A.D. 1926; TO PREVENT THE SELLING, BUYING, TRANSPORTING, GIVING AWAY, OFFERING OR EXPOSING FOR SALE, OR PURCHASING OR HAVING IN POSSESSION WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA, BEFORE THE FIRST DAY OF MAY, A. D. 1926, ANY ELK OR ELK MEAT, AND PROVIDING A PUNISHMENT FOR THE VIOLATION THEREOF.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, STATE OF NEVADA,
DO ORDAIN AS FOLLOWS:

SECTION 1: It shall be unlawful for any person or persons, firm, company, corporation or association to kill, catch, trap, hunt or pursue with an intent to capture, catch, injure or destroy any elk within the County of Washoe, State of Nevada, before the first day of May, A.D. 1926.

SECTION 2: It shall be unlawful for any person or persons, firm, company, corporation or association to have in his or their possession, or to sell, buy,

transport, give away, or offer or expose for sale, or purchase, from any person whomsoever, any elk or elk meat within the County of Washoe, State of Nevada, before the first day of May, A.D. 1926.

SECTION 3: Any person or persons, firm, company, corporation or association, or common carrier, violating any of the provisions of this ordinance, shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be fined in a sum not more than Five hundred dollars and not less than twenty-five dollars, or be imprisoned in the county jail of the County of Washoe, State of Nevada, for a term not exceeding six months or by both such fine and imprisonment.

It shall be no defense to any prosecution for the violation of Section 2 of this ordinance that the elk or elk meat was taken or killed outside of the County of Washoe, State of Nevada, nor shall it be any defense that such elk or elk meat was taken or killed by anyone other than the one in whose possession the same were found.

C. B. Company's shop, Kansas City, Mo.

ROAD SUPERVISOR.

Ordered that A. E. Hill be notified to discontinue all work on County roads until the further order of this board.
