The liquor board met pursuant to a recess taken April 14, 1917 and transacted the following business, to-wit:

RETAIL LIQUOR LICENSES.

The matter of the application of E.S. Bates for a license to retail liquor at or near 10 miles northwest of Reno, was again taken up. C.P. Ferrel moved that the application be laid over until Monday, June 5, 1917. C.D. Terwilliger seconded the motion, the chairman put the motion to the board and the roll being called, the several members of the board answered as follows, to-wit:

The application of C.F. Martin for a license to retail liquor at what was known as the Del Monte Road House was read by the clerk. C.D. Terwilliger moved that the application be granted. E.L. Drappo seconded the motion. Upon the motion being put to the board by the chairman, and the roll being called, the members of the board voted as follows, to-wit:

ORDINANCE.

The following ordinance for the regulation of the sale of liquor in Washoe County outside of incorporated cities was ordered spread upon the minutes in full, to-wit:

ORDINANCE NO. 1.

AN ORDINANCE REGULATING THE SALE OF LIQUOR AND THE CONDUCT OF SUCH PLACES AT ALL POINTS OUTSIDE THE LIMITS OF INCORPORATED CITIES WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA.

WHEREAS, the Legislature of the State of Nevada, by an Act entitled "An Act to regulate the sale of intoxicating liquors outside of the limits of any incorporated city or town; creating a liquor board in the several counties of this state; prescribing the duties and declaring the powers of such board," approved March 24, 1917, did establish a liquor board for the purposes mentioned in said Act, and declared it to be the power of such board to enact ordinances regulating the sale of intoxicating liquors in their respective counties outside the limits of incorporated cities and towns.

NOW, THEREFORE, pursuant to the provisions of said Act, the Liquor Board of the County of Washoe, State of Nevada, does hereby ordain:

Section I. That on and after the date that this ordinance goes into effect, all places where liquor is sold to be drunk on premises located outside of any incorporated or unincorporated town or city in this county, and which are hereby for the purpose of this ordinance designated "roadhouses", the following rules and regulations shall

shall be observed:

(a) All such places shall remain closed, and shall refrain from giving, selling or otherwise disposing of any liquor to any person, and shall not permit the same to be drunk on the premises, between the hours of 2:00 o'clock, A.M. and 5:00 o'clock A.M. on each and every day.

(b) No female person shall be permitted to serve liquor to any person, between the hours of 6:00 o'clock, P.M. and 5:00 o'clock A.M. of any day.

(c) No boisterous, obscene or immoral acts or conduct shall be permitted on the premises, and no rooms shall be rented to any person for any unlawful purpose, and a register shall be kept in which the true and correct names of all persons occupying rooms, and the dates thereof, shall be recorded, and open to inspection by the district attorney, any member of this board and any peace officer of this county.

SECTION 2. The following rules and regulations shall be observed by all persons retailing liquor on the premises situate outside the incorporated limits of any city or town in this county, whether they be what is hereinbefore designated "roadhouses" or be situate within the limits of any unincorporated town or city in this county.

(a) No liquor shall be served to any minor, nor to any intoxicated person or habitual drunkard, nor to any person who by reason of any infirmity is unable to properly care for himself or herself; nor shall any minor be permitted on premises where liquor is sold.

(b) No prostitute, pimp, panderer or otherwise disorderly person shall be permitted to loiter about said premises.

(c) No gambling prohibited by state law nor the playing of any slot machine in violation of the state law, shall be permitted on the said premises, nor shall any gambling device which is capable of being played in violation of the state law be maintained on said premises; and all persons operating or maintaining slot machines on their premises shall register their names with the County Auditor of the County of Washoe, and receive a permit therefor, and shall pay to said officer the sum of Fifteen Dollars (\$15.00) for each quarter or fraction thereof, for each machine operated with a single handle, and the sum of Thirty (\$30.) dollars per quarter for each machine operated with more than one handle.

SECTION 3. Each and every licensee, his agent or employee, shall aid and assist the apprehension of any person committing a crime on the premises, and shall give all information and assistance within their knowledge or possession concerning any such crime to the peace officers of the county or township, and to the district attorney.

SECTION 4. Whenever in the judgment of the liquor board there exists any place, under its jurisdiction, where the sale or disposition of liquor may tend to create or constitute a public nuisance, or where by the sale or disposition of liquor a disorderly house or place is maintained, the said board may, upon reasonable notice to said licensee, revoke the said license.

SECTION 5. Whenever, in the judgment of the majority of the members of the Liquor Board, any licensee, by himself, his agent or employee, has violated any of the terms or provisions hereof, the license may thereupon be revoked.

SECTION 6. This ordinance shall be in effect on and after the 1st., day of July, 1917, and the County Clerk of Washoe County, as ex-officio clerk of this board is hereby authorized and ordered to forthwith cause this ordinance to be published daily in the Nevada State Journal for a period of one week.
