The board met pursuant to statute and transacted the following business, to-wit:

MINUTES.

The minutes of October 6th, 7th, 8th, 13th, 14th, and 17th, were read and approved.

FISH AND GAME

A committee from the Washoe County Sportsman Club, appeared before the board and asked the commissioners to pass an ordinance making the open season for valley quail from November 20 to December 1st; also asked for the resignation of L.K. Gregory was ^{deputy} game warden from Washoe County. On motion duly seconded and carried by the unanimous vote of the board, it was ordered that the following ordinance be adopted in full, forwarded to the State Game Warden for his approval and published in the Nevada State Journal for 4 issues, to-wit:

AN ORDINANCE TO PROVIDE FOR THE PROTECTION AND PRESERVATION OF VALLEY QUAIL AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

The Board of County commissioners of Washoe County, State of Nevada do ordain as follows:

Section I. It shall be unlawful for any person or persons, firm, company, corporation or association, at any time from December 1st and before November 20th, of each and every year, to kill, catch, net, cage, pound, weir, trap or pursue with attempt to catch, capture, injure or destroy any valley quail within the boundaries of Washoe County, in the State of Nevada;

Section II. It shall be unlawful for any person or persons to purchase any valley quail for the purpose of barter or sale, and it shall be also unlawful for any person to kill, or have in his or her possession a greater number than ten valley quail in any one day during the open season.

Section III. Any person or persons, company, corporation or association violating any of the provisions of this ordinance shall be fined in any sum not less than fifty dollars nor more than five hundred dollars, or imprisonment in the county jail for any term not exceeding six months or by both such fine and imprisonment;

Section IV. This Ordinance is passed and adopted in accordance with Section 38 of Chapter 239, Statutes of 1917, and shall take effect from and after the date of its passage and approval by the State Fish and Game Warden.

Passed by the Board of County Commissioners of Washoe County, State of Nevada, this 5th day of November, 1919 by unanimous vote of the said County Commissioners.
