AN ORDINANCE CHANGING THE OPEN SEASON AND LENGTHENING THE TIME OF THE CLOSED season for the killing, catching, trapping, wounding, or pursuing with the attempt to catch, capture, injure, or destroy antelope within the county of Washoe, State of Nevada, and to provide for the protection and preservation of Antelope within the county of Washoe,

STATE OF NEVADA.

The board of county commissioners of the county of Washoe, state of Nevada, acting under the authority of that certain act of the Legislature, entitled "An Act to provide for the protection and preservation of fish and game, providing for the protection and preservation of fish and game, providing penalties for the violation thereof, and repealing all acts or parts of acts in conflict herewith," approved March 27, 1917, amended March 23, 1921, and upon petition of more than fifty resident; electors of Washoe County, which petition has been duly and regularly filed and said board, do ordain:

SECTION 1. It shall be unlawful for any person, persons, firm, company, corporation, or association to kill, catch, capture, or destroy, after the hour of eight O'clock A. M. on the 10th. day of November of each and every year and before the hour of seventhirty o'clock A. M. on the 10th. day of November of each and every year, any antelope within the county of Washoe, state of Nevada.

SEC. 2. Any person, persons, firm, company, corporation, or association violating any of the provision of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished as provided in that certain act of the Legislature, entitled, "An act to provide for the protection and preservation of fish and game, providing penalties for the wickstien thereof, and repealing all acts or parts of acts in conflict herewith", approved March 27, 1917, amended March 23, 1921.
