ORDINANCE

AN ORDINANCE TO PREVENT FIRES BY REASON OF LIGHTED CIGARETTES, CIGARS, MATCHES, OR ASHES.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. It shall be unlawful for any person to, either wilfully or negligently, throw or place any lighted cigarette, cigar, match, or ashes in any place where such lighted cigarette, cigar, match, or ashes may cause a fire.

SECTION 2. It shall be unlawful for any person to, either wilfully or negligently, throw or place from a moving vehicle any lighted cigarette, cigar, match, or ashes which may cause a fire.

SECTION 5. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than fifteen dollars nore more than five hundred dollars, or by imprisonment in the county jail for not more than six months, or by both such fine and imprisonment.
