## ORDINANCE NO. 1

AN ORDINANCE TO ADOPT AND MAKE OPERATIVE IN THE COUNTY OF WASHOE AN ACT OF THE LEGISLATURE OF THE STATE OF NEVADA, ENTITLED "AN ACT TO PROVIDE FOR THE ESTABLISHMENT, MAINTENANCE AND OPERATION OF LAW LIBRARIES IN THE VARIOUS COUNTIES OF THIS STATE, AND REPEALING ALL OTHER ACTS AND PARTS OF ACTS IN CONFLICT THEREWITH, " APPROVED MARCH 25, 1913.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Adoption of state act concerning law libraries. The provisions of that certain act of the Legislature of the State of Nevada entitled "An Act to provide for the establishment, maintenance and operation of law libraries in the various counties in this state, and repealing all other acts and parts of acts in conflict therewith, " approved March 25, 1913, are hereby adopted and made operative in the County of Washoe, State of Nevada.

Section 2. Law Library Fund: Fees set aside. On the commencement in, or removal to, the District Court of Washoe County of any civil action, proceeding or appeal, on filing the first papers therein, the clerk of the court shall set aside from the costs received the sum of \$3 in each case for a fund which shall be and is hereby designated as the "Law Library Fund" to be expended in the purchase of law books and periodicals and in the establishment and maintenance of a law library in the county seat of the county, which law library shall be governed and controlled as provided for in the act of the Legislature of the State of Nevada.

Section 3. Board of trustees. Duties of chairman, secretary. The chairman and secretary of the board of trustees of the law library are hereby directed immediately upon their election or appointment and qualification to notify the Secretary of State that the act of the Legislature of Nevada has been adopted in the County of Washoe and under the direction of the board of trustees to take such steps, and do such things as are necessary, requisite or proper to secure from the Secretary of State and the Librarian of the State Library, books and properties authorized by the Secretary of State, and the Librarian to be provided for the use of the library, and which are or may hereafter be available for such purpose.
