Any permit which may be issued pursuant to the 4 provisions of this ordinance under which the work authorized is 5 not commenced within one year from the time of issuance shall 6 expire and thereafter be of no force and effect; provided, how-7 ever, that once work is commenced as authorized in any permit it 8 shall thereafter be prosecuted diligently to completion and fail-9 ure of a permitee to so diligently prosecute such work to com-10 pletion shall be ground for revocation of said permit. 11 SECTION 4. All ordinances and parts of ordinances in con-12 flict with this ordinance are hereby expressly repealed. 13 SECTION 5.
