ORDINANCE NO. 11

AN ORDINANCE TO AMEND SECTION 1, TO PROVIDE FOR PERMISSION BY THE BOARD OF COUNTY COMMISSIONERS TO DISPLAY FIREWORKS IN WASHOE COUNTY, OF COUNTY ORDINANCE NO. 11 ENTITLED: "AN ORDINANCE TO PROHIBIT THE POSSESSION, SALE, STORAGE OR HANDLING OF ROCKETS, SQUIBS, FIRECRACKERS, ROMAN CANDLES OR OTHER FIREWORKS OR BLANK CARTRIDGES, AT ALL PLACES OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 1 of County Ordinance No. 11 is hereby amended
to read as follows:

## Section 1. Possession of fireworks unlawful, exceptions.

- A. Except as hereinafter provided it shall be unlawful for any person, firm, association or corporation to have in their possession, or under their control, for sale or otherwise, or to store or otherwise handle within the County of Washoe, State of Nevada, outside of the limits of incorporated cities and towns, within said County of Washoe, any rockets, squibs, firecrackers, roman candles or any fireworks of any description whatsoever, or any blank cartridges for what is known as cap pistols.
- B. Upon application by any person, firm, association or corporation for permission for fireworks displays in the unincorporated area of Washoe County, the Board of County Commissioners may grant such permission, notwithstanding Subsection A of Section 1, in writing, upon such conditions as the Board of County Commissioners deem necessary to protect the public interest.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100. Proposed on the 15th day of June , 1966.
