No. 146, Ordinance No. 35, AN ORDINANCE TO AMEND SECTION 2 (1) DEFINING TRAILER COACH PARK OF COUNTY ORDINANCE NO. 35 ENTITLED: "AN ORDINANCE OF WASHOE COUNTY, STATE OF NEVADA, REGULATING THE CONSTRUCTION, USE AND OPERATION OF TRAILER COACH PARKS: PROVIDING PENALTIES FOR VIOLATIONS HEREOF AND OTHER MATTERS PROPERLY RELATING THERETO," was proposed on April 5, 1966 by Commissioner Cunningham and final action of adoption was taken on April 15, 1966.

SUMMARY: An ordinance amending Ordinance No. 35, Section 2(i) to change the definition of Trailer Coach Park.

BILL NO. 146

ORDINANCE NO. 35

AN ORDINANCE TO AMEND SECTION 2(i) DEFINING TRAILER COACH PARK OF COUNTY ORDINANCE NO. 35 ENTITLED: "AN ORDINANCE OF WASHOE COUNTY, STATE OF NEVADA, REGULATING THE CONSTRUCTION, USE AND OPERATION OF TRAILER COACH PARKS; PROVIDING PENALTIES FOR VIOLATIONS HEREOF AND OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 2(i) of County Ordinance 35 is hereby amended to read as follows:

- (i) Trailer Coach Park: Any parcel of land upon which two or more trailer coaches occupied for dwelling or sleeping purposes are located, regardless of whether or not a charge is made for such accommodation, and shall include any building, structure, tent, vehicle or enclosure used or intended for use as a part of the equipment of such trailer coach park. A trailer coach park as defined herein shall not include the leasing of separate parcels of land for trailer use provided such action complies with the applicable land use zone provided by County Ordinance 57.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
