SUMMARY - Establishing Speed Limit on South Verdi Highway and providing penalty for violation.

Ordinance No. 44

AN ORDINANCE ESTABLISHING A SPEED LIMIT ON SOUTH VERDI HIGHWAY COMMENCING AT THE INTERSECTION OF HUNTER LAKE DRIVE OF THE CITY OF RENO WEST U.S. HIGHWAY 40 IN WASHOE COUNTY, NEVADA; PROVIDING THE PENALTY FOR VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1: That on South Verdi Highway, commencing at the intersection of Hunter Lake Drive of the City of Reno west to U. S. Highway 40 in Washoe County, Nevada, the maximum speed limit for all motor vehicles is hereby established at thirty-five (35) miles per hour.

SECTION 2: Any person who drives, propels, operates or conducts any motor vehicle on said South Verdi Highway within said area at a rate of speed exceeding thirty-five (35) miles per hour shall be guilty of a misdemeanor and shall be punished by a fine not exceeding Five Hundred (\$500.00) Dollars or imprisonment in the County Jail in Washoe County, Nevada, not exceeding six (6) months or by both such fine and imprisonment.
