ORDINANCE ESTABLISHING A  
SPEED LIMIT ON THAT PORTION OF  
MOANA LANE FROM THE COR-  
CORAN DITCH WEST TO PLUMAS  
STREET, LYING IN WASHOE  
COUNTY, NEVADA, PROVIDING A  
PENALTY FOR THE VIOLATION  
THEREOF, AND OTHER MATTERS  
PROPERLY RELATING THERETO,  
was proposed on February 20th, 1957  
by Commissioner Caputo; final action  
of adoption taken on March 5th, 1957  
by the following vote:

6 AN ORDINANCE ESTABLISHING A SPEED LIMIT ON THAT  
7 PORTION OF MOANA LANE FROM THE CORCORAN DITCH  
8 WEST TO PLUMAS STREET, LYING IN WASHOE COUNTY,  
9 NEVADA; PROVIDING A PENALTY FOR THE VIOLATION  
10 THEREOF; AND OTHER MATTERS PROPERLY RELATING  
11 THERETO.

12 THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO  
13 ORDAIN:

14 Section 1: On that portion of Moana Lane commencing at the Corcoran  
15 an Ditch, Washoe County, Nevada, and continuing west to Plumas  
16 Street, the maximum for all motor vehicles is hereby established  
17 at Twenty-five (25) miles per hour.

18 Section 2: Any person who drives, propels, operates or conducts  
19 any motor vehicle on said portion of Moana Lane at a rate of  
20 speed exceeding twenty-five (25) miles per hour shall be guilty  
21 of a misdemeanor and shall be punished by a fine not exceeding  
22 Five Hundred (\$500.00) Dollars or imprisonment in the County Jail  
23 in Washoe County, Nevada, not exceeding six (6) months or by both  
24 such fine and imprisonment.

25 Section 3: This Ordinance shall be in effect from and after its  
26 passage and approval.
