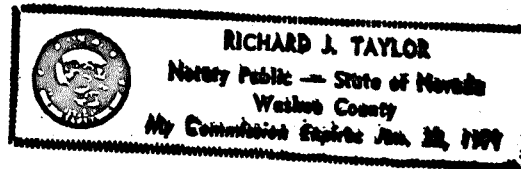

Notice is hereby given that Bill No. 195, Ordinance No. 55, AN ORDINANCE TO AMEND SECTION 1 OF COUNTY ORDINANCE NO. 35 ENTITLED: "AN ORDINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE AND COLLECT AN ADDITIONAL FEE FOR MARRIAGE LICENSES ISSUED BEFORE OR AFTER REGULAR OFFICE HOURS, PROVIDING FOR THE PAYMENT THEREOF TO THE COUNTY GENERAL FUND AND OTHER MATTERS PROPERLY RELATING THERETO," was proposed on October 5, 1967 by Commissioner McKenzie and final action of adoption was taken on October 16, 1967.

BILL NO. 195

ORDINANCE NO. 55

AN ORDINANCE TO AMEND SECTION 1 OF COUNTY ORDINANCE NO. 55 ENTITLED: "AN ORDINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE AND COLLECT AN ADDITIONAL FEE FOR MARRIAGE LICENSES ISSUED BEFORE OR AFTER REGULAR OFFICE HOURS. PROVIDING FOR THE PAYMENT THEREOF TO THE COUNTY GENERAL FUND AND OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Section 1 of County Ordinance No. 55 is hereby amended to read as follows:

From and after the effective date of this ordinance, the County Clerk of Washoe County shall charge and collect, over and above the charge and collection of those fees provided by NRS §122.060, as amended, additional fees for the issuance of marriage licenses after regular office hours as follows:

- A. Five Dollars (\$5.00) for each such license issued during the ~~period~~ commencing with the effective date of this ordinance and ending December 31, 1967.
- B. Nine Dollars (\$9.00) for each such license issued after January 1, 1968.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
