WHEREAS, the Clerk of the Board of Trustees of the Washoe County School District, in the County of Washoe and State of Nevada, has transmitted certified copies of the the resolution adopted and approved by said Board on the 25th. day of August, 1959, to the County Clerk and to the Board of County Commissioners of Washoe County; and

WHEREAS, NRS 387.360, provides, in subsection 2 thereof, that immediately upon receipt of a certified copy of the resolution calling a special school election, the Board of County Commissioners and the County Clerk shall perform the duties required by law for holding elections in the several counties; and

WHEREAS, in the opinion of this Board the immediate need of the people of this County for adequate school facilities necessitates that this ordinance be adopted and take effect at the earliest possible date, the Board of County Commissioners has deemed, and does hereby declare, that an emergency exists requiring this ordinance to take effect from and after its passage and publication by title in accordance with law.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE
IN THE STATE OF NEVADA, DOES ORDAIN:

Section 1. That all action heretofore taken (not inconsistent with the provisions of this ordinance) by the Board of Trustees of the Washoe County School District, the officers thereof, and the officers of Washoe County, directed toward improving the District's school facilities, by constructing new school buildings, enlarging and repairing existing school buildings, acquiring school building sites and additional real property for necessary school purposes, and purchasing necessary school equipment therefor, be, and the same hereby is, ratified, approved and confirmed, including, without limiting the generality of the foregoing, the adoption by said Board of Trustees of said resolution on the 25th day of August, 1959, and action taken pursuant thereto.

Section 2. That the polling places, precincts and precinct boundaries for said school district election shall be the same as those designated for the Washoe County Convention Hall and Recreation Bond Election, held the 28th. day of July, 1959.

Section 3. That at least fifteen days preceding said school district election, the Board of County Commissioners shall appoint suitable persons who are citizens and qualified voters in Nevada, in Washoe County and in the precinct where they are appointed, at least three such persons to act as inspectors in each precinct and two such persons therein to act as clerks of said election. Said inspectors and clerks shall be the election officers for said election, shall have charge of the ballots on the date of said election, and shall perform such duties in holding said election, and make due return thereof as required by the general election laws of the State of Nevada insofar as the same are not inconsistent with the provisions of Title 34 NRS.

Section 4. That said school district election shall be conducted in the manner provided by said Title 34, by said resolution, and as nearly as practicable by Chapter

296 NRS, as if it were a county election; and the County Clerk and his deputies shall do all things in connection with said election required by said Title 34, as supplemented by said resolution of the Board of Trustees of the Washoe County School District, and as nearly as practicable and to the extent not inconsistent with said Chapter 296 NRS, and said Title 34 NRS, including, without limiting the generality of the foregoing, the providing of printed ballots, furnishing of the ballot boxes for the several precincts, and the procuring of any and all necessary materials, equipment and supplies, required by said laws; provided, however, that all expenses incurred in holding the school district election shall be borne by the District, including but not limited to the expenses of printing necessary ballots and forms of affidavit, pursuant to NRS 387.360.

Section 5. That the County Clerk shall give notice of the action hereby taken by transmitting to the Clerk of said Board of Trustees a certified copy of this ordinance.
