ORDINANCE NO. 127

AN ORDINANCE OF THE COUNTY OF WASHOE ADOPTING A POSITION CLASSIFICATION MANUAL AND A PAY PLAN FOR EMPLOYEES OF WASHOE COUNTY, WHOSE DUTIES AND COMPENSATION ARE NOT PRESCRIBED BY THE CONSTITUTION OR STATUTES OF THE STATE OF NEVADA, CREATING A COUNTY JOB CLASSIFICATION AND SALARY COMMITTEE, AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 1, County Ordinance No. 127 is hereby amended to read as follows:

Section 1. Position Classification Manual.

The Position Classification Manual for Washoe County employees dated April 1967, Revised Edition, is hereby adopted as the Position Classification Manual of the County of Washoe for employees of Washoe County, whose duties are not prescribed by the Constitution or Statutes of the State of Nevada, and the provisions and terms of said Manual on file in the office of the County Clerk of Washoe County are hereby referred to, adopted, and made a part hereof as if fully set out in this Ordinance.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
