SUMMARY: Amends County Ordinance No. 127 by suspending the operation of the longevity pay plan and removing the Personnel Administrator as Secretary for the County Job Classification and Salary Committee.

ORDINANCE NO. 127

AN ORDINANCE TO AMEND COUNTY ORDINANCE NO. 127 ENTITLED "AN ORDINANCE OF THE COUNTY OF WASHOE ADOPTING A POSITION CLASSIFICATION MANUAL AND A PAY PLAN FOR EMPLOYEES OF WASHOE COUNTY, WHOSE DUTIES AND COMPENSATION ARE NOT PRESCRIBED BY THE CONSTITUTION OR STATUTES OF THE STATE OF NEVADA, CREATING A COUNTY JOB CLASSIFICATION AND SALARY COMMITTEE, AND OTHER MATTERS PROPERLY RELATING THERETO," BY SUSPENDING THE LONGEVITY PAY PLAN AND REMOVING THE PERSONNEL ADMINISTRATOR AS SECRETARY FOR THE COUNTY JOB CLASSIFICATION AND SALARY COMMITTEE; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Paragraph B of section 2 of the above-entitled ordinance, relating to the longevity pay plan, is hereby suspended until further action of the Board of County Commissioners of Washoe County. For the fiscal year 1972-1973, the salary schedule adopted by resolution on July 5, 1972, is the sole salary schedule applicable to salaries of Washoe County employees during fiscal year 1972-1973.

Section 2. Section 3 of the above-entitled ordinance is hereby amended to read as follows:

Section 3. County Job Classification and Salary Committee. There is hereby created an advisory committee to be known as the "County Job Classification and Salary Committee." The Committee shall be appointed by the Board of County Commissioners and shall be composed of five county department heads. At least three appointees shall be elected county officials. The appointees to the Committee shall serve at the pleasure of the Board of County Commissioners and shall elect a Chairman. The County Manager and the District Attorney shall be ex officio members of the Committee; the County Manager shall provide secretarial assistance for the Committee. The County Manager and District Attorney shall serve in an advisory capacity to the Committee without the right to vote.

- A. The duties of the Committee shall be as follows:
 - 1. To propose and, subject to the approval of the Board of County Commissioners, adopt and promulgate regulations for the implementation and interpretation of the Position Classification Manual and the Pay Plan adopted by this Ordinance.
 - To propose amendments to the Position Classification Manual and the Pay Plan to the Board of County Commissioners.

3. To hear complaints from county employees regarding the Pay Plan and the Position Classification Manual. After such hearing the Committee shall make recommendations in writing to the Board of County Commissioners with regard to the disposition of the case. This responsibility of the Committee shall not bar any county employee from appearing before the Board of County Commissioners with regard to the Pay Plan or the Position Classification Manual. However, all county employees covered by the Position Classification Manual and the Pay Plan must appear first before the Committee with regard to either the Position Classification Manual or the Pay Plan.

To accomplish these duties the Committee shall meet from time to time as necessary and shall review the entire Pay Plan and Position Classification Manual at least once every two years. The Chairman shall call meetings of the Committee when necessary.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed but only to the extent that they are in conflict with this Ordinance.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
