ORDINANCE NO. 159

AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 159 TO REQUIRE THAT BIDS BE PUBLICLY OPENED FIVE BUSINESS DAYS PRECEDING A REGULARLY SCHEDULED MEETING OF THE BOARD OF COUNTY COMMISSIONERS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1.
Section 8C(2) of Washoe County Ordinance No. 159 is hereby amended to read as follows:

All authorized notices to bidders shall specify that the bids made in response to such notices shall be opened at a time certain five (5) business days preceding a regularly scheduled Commissioners' meeting. The bid openings shall be held in a public place to be stated in the notice to bidders, at which any bidder and the public may be present. The County Purchasing Agent, the County Clerk or his deputy, and a representative of the Department requesting the materials or services to be purchased, shall be present at the bid opening. All bids shall be opened at the stated time and publicly announced. At the next regular meeting+ day of the Board of Commissioners of Washoe County, the Purchasing Agent shall report to the Commissioners in writing his recommendations concerning the bids, together with a copy of the tabulation of all bids received. The bids, tabulation of bids and all materials accompanying the bids shall be delivered to the County Manager no later than 9:30 A.M. on the morning of the fourth business day following the bid opening.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
