AN ORDINANCE AMENDING ORDINANCE NO. 177 BY DELETING REQUIREMENT THAT ALL UTILITIES BE PLACED UNDERGROUND IN MOBILE HOME SUBDIVISIONS AND AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS TO REQUIRE UNDERGROUND UTILITIES.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
Article 3, Section B.6, of Washoe County Ordinance No. 177 is hereby amended to read as follows:

6. <u>Utilities</u>: The Board of County Commissioners may require the underground placement of utilities.

SECTION 2.
This Ordinance shall be in full force and effect from and after its approval, passage and publication pursuant to NRS 244.100.
