SUMMARY: Establishes fees for the solemnization of marriages by the Office of the Commissioner of Civil Marriages, authorizes hours of operation for the Office of the Commissioner of Civil Marriages to be established by the Commissioner, provides for payment of salaries at the rate of time and one half for employees in the Office of the Commissioner of Civil Marriages and Marriage License Bureau for Sundays and holidays.

ORDINANCE NO. 182

AN ORDINANCE ESTABLISHING FEES FOR SOLEMNIZATION OF MARRIAGES BY THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES, AUTHORIZING THE HOURS OF OPERATION FOR THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES TO BE ESTABLISHED BY THE COMMISSIONER, PROVIDING FOR PAYMENT OF SALARIES AT THE RATE OF TIME AND ONE HALF TO EMPLOYEES OF THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES AND MARRIAGE LICENSE BUREAU FOR SUNDAYS AND HOLIDAYS, AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

The Commissioner of Civil Marriages or his deputies shall charge and collect fees for the solemnization of marriages as follows:

- A. Fifteen (\$15.00) Dollars for each solemnization of marriage performed during the hours of 8:00 A.M. to 4:00 P.M., Monday through Friday.
- B. Twenty (\$20.00) Dollars for each solemnization of marriage performed during the hours of 4:00 P.M. to 12:00 Midnight, Monday through Friday.
- C. Twenty (\$20.00) Dollars for each solemnization of marriage performed during the hours of 8:00 A.M. to 12:00 Midnight on Saturdays, Sundays and holidays.

SECTION 2.
The hours of operation for the Office of the Commissioner of Civil Marriages shall be established by the Commissioner of Civil Marriages in his sole discretion.

SECTION 3.
All fees collected in accordance with Section 1 of this Ordinance shall be deposited with the County Treasurer for deposit to the General Fund.

SECTION 4.
Salaries of the employees of the Office of the Commissioner of Civil Marriages and Marriage License Bureau shall be paid at the rate of time and onehalf for work performed on Sundays and legal holidays.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
