BILL NO. 319

ORDINANCE NO. 200

AN ORDINANCE REQUIRING ALL WASHOE COUNTY DEPARTMENTS, AGENCIES AND OFFICES TO MAINTAIN TELEPHONE TOLL CALL LOGS; AUTHORIZES COUNTY MANAGER TO PRESCRIBE FORMS FOR TOLL CALL LOGS AND REGULATIONS RELATING TO MAINTENANCE AND DISPOSITION OF SUCH LOGS; AND PROVIDES OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

From and after the 1st day of April, 1973, all Washoe County Departments, Agencies and Offices shall maintain a telephone toll log for the purpose of acquiring and maintaining an accurate record of all toll call charges incurred by the County of Washoe.

SECTION 2.

The County Manager of Washoe County is hereby authorized and directed to prescribe forms for toll call logs and directions to the various County Departments, Agencies and Offices for the maintenance and disposition of said toll call logs. The County Manager may prescribe different forms, maintenance and reporting requirements for different Departments, Agencies and Offices.

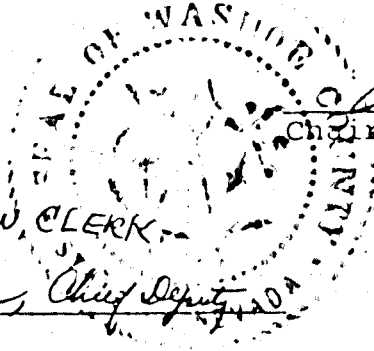
SECTION 3.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
