NOTICE OF COUNTY ORDINANCE
Notice is hereby given that Bill No. 373, amending Ordinance No. 205 entitled, "An ordinance providing for accident reports after the occurrence of any accident to a vehicle owned by Washoe County and driven by a Washoe County employee; allowing appointment of accident evaluation boards by the County Manager; providing for duties of County employees, accident evaluation boards, the County Manager, the Sheriff and Department Heads relating to each accident; providing for the preparation of statistical information and accident-prevention measures; allowing disciplinary action against employee involved in accidents while driving county vehicles; and providing other matters properly relating thereto", was adopted on March 15, 1974 by Commissioners Rusk, Nelson, Pagni, Grow and Scott all voting aye.

ORDINANCE NO. 205

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE PROVIDING FOR ACCIDENT REPORTS AFTER THE OCCURRENCE OF ANY ACCIDENT TO A VEHICLE OWNED BY WASHOE COUNTY AND DRIVEN BY A WASHOE COUNTY EMPLOYEE; ALLOWING APPOINTMENT OF ACCIDENT EVALUATION BOARDS BY THE COUNTY MANAGER; PROVIDING FOR DUTIES OF COUNTY EMPLOYEES, ACCIDENT EVALUATION BOARDS, THE COUNTY MANAGER, THE SHERIFF AND DEPARTMENT HEADS RELATING TO EACH ACCIDENT; PROVIDING FOR THE PREPARATION OF STATISTICAL INFORMATION AND ACCIDENT-PREVENTION MEASURES; ALLOWING DISCIPLINARY ACTION AGAINST EMPLOYEES INVOLVED IN ACCIDENTS WHILE DRIVING COUNTY VEHICLES; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Subsection B of Section 3 of Washoe County Ordinance No. 205 is hereby amended to read as follows:


B. Such disciplinary action as recommended may be imposed pursuant to the provisions of sections 137 to 141, inclusive, of Washoe County Ordinance No. 213.

Section 2. This ordinance shall be effective immediately upon its passage and approval.
