AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 57 BY AMENDING THE LAND USE PLAN CHANGING THE USE OF THAT AREA SITUATED ON THE NORTH SIDE OF OLD U. S. 395 NORTH, SECTION 8, T20N, R19E, M.D.B. &M., COUNTY OF WASHOE, STATE OF NEVADA, FROM A-1 and TR (FIRST AGRICULTURAL WITH TRAILER OVERLAY) TO C-2 (GENERAL COMMERCIAL), AND CHANGING THE USE OF CERTAIN PROPERTY IN COLD SPRINGS VALLEY, COUNTY OF WASHOE, STATE OF NEVADA, FROM A-1 (FIRST AGRICULTURAL) TO C-2 (GENERAL COMMERCIAL) AND M-1 (INDUSTRIAL); AND OTHER MATTERS PROPERLY RELATING THERETO.
