NOTICE OF COUNTY ORDINANCE

Notice is hereby given that Bill No. 497, Ordinance o. 331, amending Washoe County Ordinance No. 221, entitled "An ordinance amending an Ordinance designating congested areas within he unincorporated area of Washoe County for purposes of animal ontrol; prohibiting animals trespassing on private rezidential roperty or county property within congested areas; providing or the impounding of animals found in violation of the prosisions of this ordinance; providing regulations of impounding, satruction or auction and release of impounded animals; provides or impounding of livestock in the county which are endangering rivate or public property, public safety, themselves, or other immals; providing penalties for the noncompliance of the prolations hereof; and other matters properly relating thereto," is adopted on September 7, 1976 by Commissioners Scott, Grow, sek, Nelson and Gaunt all voting aye.

AN ORDINANCE AMENDING AN ORDINANCE DESIGNATING CONGESTED AREAS WITHIN THE UNINCORPORATED AREA OF WASHOE COUNTY FOR PURPOSES OF ANIMAL CONTROL; PROHIBITING ANIMALS TRESPASSING ON PRIVATE RESIDENTIAL PROPERTY OR COUNTY PROPERTY WITHIN CONGESTED AREAS; PROVIDING FOR THE IMPOUNDING OF ANIMALS FOUND IN VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING REGULATIONS OF IMPOUNDING, DESTRUCTION OR AUCTION, AND RELEASE OF IMPOUNDED ANIMALS; PROVIDES FOR IMPOUNDING OF LIVESTOCK IN THE COUNTY WHICH ARE ENDANGERING PRIVATE OR PUBLIC PROPERTY, PUBLIC SAFETY, THEMSELVES, OR OTHER ANIMALS; PROVIDING PENALTIES FOR THE NONCOMPLIANCE OF THE PROVISIONS HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO.
