SUMMARY: An Ordinance creating a Regional Planning Commission.

BILL NO. 620 ORDINANCE NO. 449

AN ORDINANCE DEFINING A REGIONAL PLANNING DISTRICT; EMPOWERING A REGIONAL PLANNING COMMISSION TO ACT FOR AND ON BEHALF OF THE COUNTY OF WASHOE IN ALL PLANNING DUTIES AND PLANNING FUNCTIONS; PROVIDING FOR THE APPOINTMENT AND COMPENSATION OF CERTAIN OF THE MEMBERS OF THE PLANNING COMMISSION, THE APPROPRIATION OF FUNDS FOR EXPENSES OF THE PLANNING COMMISSION, AND OTHER MATTERS PROPERLY RELATING THERETO, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Washoe County Part of Regional Planning District. The County of Washoe is hereby declared to be part of Regional Planning District, the boundaries of which District shall be the boundaries of Washoe County, Nevada.

SECTION 2. Representation of County on Planning Commission. The County of Washoe shall be represented in a Regional Planning Commission, which Commission is hereby authorized to act for and on behalf of the County of Washoe as a Planning Commission which shall fulfill all of the duties and functions of a Planning Commission as set forth in the enabling act, NRS 278.090 to 278.260, inclusive.

SECTION 3. Membership; Election of Sparks to Participate.

- 1. The membership of the Regional Planning Commission shall be 8 members, 4 of whom shall be appointed by the City of Reno and 4 of whom shall be appointed by Washoe County.
- 2. In the event the City of Sparks elects to be represented on the Regional Planning Commission, the total membership shall be 12 members and the City of Sparks shall appoint 4 members.

SECTION 4. Appointments, Terms of County Members. The Board of County Commissioners shall appoint 4 members of the Regional Planning Commission. The terms of the members so appointed shall commence on January 1, 1980. The terms of 2 of the members first appointed shall be 3 years; 1 member 2 years; and 1 member 1 year. Thereafter, all terms shall be for 4 years. No more than one-third of the members shall hold any other public office.

SECTION 5. Members: Service without compensation: Removal; vacancies. All members of the Regional Planning Commission shall serve without compensation. They may be removed, after public hearing, by a majority vote of the Board of County Commissioners for inefficiency, neglect of duty or malfeasance of office. Vacancies occurring other than through the expiration of the term of office shall be filled for the period of the unexpired term.

SECTION 6. Finances; personnel; appropriation of funds for commission use.

- 1. The Regional Planning Commission shall:
 - (a) Prepare an annual budget containing a detailed estimate of expenditures and transmit copies thereof to the budget officers of Washoe County and the City of Reno for their use in complying with the provisions of the Local Government Budget Act.
 - (b) Employ necessary personnel to perform the duties imposed by law.
- 2. The Board of County Commissioners shall appropriate funds annually for the use of the Regional Planning Commission, such funds to be made a part of the budget of Washoe County. The Regional Planning Commission shall have no authority to expend any funds of Washoe County in excess of those as appropriated, but may negotiate for gifts, federal or state grants, or other funds, and may expend the same only within the total amounts as acquired. SECTION 7. Ordinance No. 101 Repealed. Washoe County Ordinance No. 101 is repealed effective January 1, 1980.
