SUMMARY: An ordinance providing for the establishment and operation of Citizens Advisory Boards as authorized by Chapter 257 of the 1979 Statutes of Nevada.

ORDINANCE NO. 468

AN ORDINANCE OF THE COUNTY OF WASHOE CREATING AND ESTABLISHING CITIZENS ADVISORY BOARDS; REESTABLISHING EXISTING BOARDS; PROVIDING FOR THE APPOINTMENT, TERMS AND FILLING OF VACANCIES OF THE MEMBERSHIP OF CITIZENS ADVISORY BOARDS; PROVIDING FOR OFFICERS AND A BUDGET FOR SUCH BOARDS; AND PROVIDING FOR BYLAWS FOR SUCH BOARDS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Purpose.

The purpose of this ordinance is to establish Citizens Advisory Boards to assist the Washoe County Board of Commissioners in an advisory and liaison capacity on any County matter about which the Board desires study or advice. The advisory board shall in no way be construed to diminish the authority of the Board of County Commissioners over the subject area.

SECTION 2. Existing Boards.

Any citizens advisory boards existing prior to the enactment of this ordinance shall be deemed to be reestablished as of the date of this ordinance and bound by its provisions.

SECTION 3. Establishment of Boards.

The Washoe County Board of Commissioners may establish Citizens Advisory Boards, in accordance with the purpose of Section 1 by resolution. Such resolution shall state the specific purposes of the Citizens Advisory Board and the number and category of membership positions in accordance with Section 4(a).

SECTION 4. Membership.

- A. Appointment. Membership of the Citizens Advisory Boards shall consist of a number of citizens adequate to represent a cross section of the community involved. Ads seeking applications from interested citizens shall be placed in the news media as well as being posted in four separate, prominent places within the County, including the community involved. After advertising, the members shall be chosen by the Washoe County Board of Commissioners from among those citizens who have submitted their names to the Commission for selection.
- B. Officers. Upon selection, the initial members shall meet to select their officers which at the minimum shall consist of a Chairman, Co-Chairman, and Secretary/Treasurer. The Secretary/Treasurer shall be responsible for taking a monthly report to the Washoe County Board of Commissioners on the activities of the Citizens Advisory Board.
- C. Terms. The regular term of membership shall be two (2) years. Initially, the Chairman and half of the remaining members shall serve two (2) years, and the other half

of the members for one (1) year. Thereafter all members shall serve for two (2) years. A member may be reappointed by the Washoe County Board of Commissioners at the end of his term, but no member shall serve more than three (3) consecutive terms.

- D. Vacancies. Vacancies on the Advisory Boards shall be filled by the Board of County Commissioners for the balance of any unexpired term.
- E. Removal. A member may be removed by a majority vote of the Washoe Board of County Commissioners for inefficiency, neglect of duty, or malfeasance of office.

SECTION 5. Bylaws.  
 At the first organizational meeting the members shall draft Bylaws to govern their affairs. These Bylaws shall be presented for approval by the Washoe County Board of Commissioners and shall have no affect until their acceptance by the Commission. In the event the members cannot in good faith draft acceptable Bylaws the Washoe County Board of Commissioners shall establish Bylaws to govern the Citizens Advisory Board. Any subsequent amendments to the Bylaws shall be approved by the Washoe County Board of Commissioners.

SECTION 6. Budget and Compensation.  
 The Washoe County Board of Commissioners shall annually establish a budget to meet the operating expenses of the Citizens Advisory Board. Members shall be reimbursed for necessary expenses but shall otherwise serve without compensation.

SECTION 7. Termination of Boards.  
 The Washoe County Board of Commissioners may terminate by resolution a Citizens' Advisory Board if a majority of the Board of Commissioners find that the Citizens' Advisory Board is no longer needed for the purpose for which it was established.
