AN ORDINANCE AMENDING "AN ORDINANCE CREATING A COUNTY DEPART-MENT OF WELFARE; SETTING UP AN ADVISORY BOARD, DEFINING THE DUTIES OF THE ADVISORY BOARD, PROVIDING FOR THE APPOINTMENT OF A WELFARE DIRECTOR AND DEFINING THE DUTIES OF THE WELFARE DIRECTOR, PROVIDING STANDARDS FOR ELIGIBILITY FOR COUNTY MEDICAL CARE" BY INCREASING THE NUMBER OF MEMBERS ON THAT BOARD.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

ARTICLE 1. Article 3 of Washoe County Ordinance No. 68 is hereby amended to read as follows:

ARTICLE 3. ADVISORY BOARDS.

SECTION 1.

The Advisory Board of the Washoe County Department of Welfare shall consist of not less than six members appointed by the Director, with the advice and consent of the Commissioners, on the basis of their experience and interest in civic affairs and matters of public welfare. Members of the Board serve at the pleasure of the Commissioners. Members' services shall be contributed voluntarily and without any compensation, remuneration or the payment of any expenses which they may incur. The Board, at its first meeting shall elect a Chairman from among its members, as well as such other officers of the Board as it may, from time to time, deem necessary.
