ORDINANCE NO. 620

AN ORDINANCE AMENDING CHAPTER 80 OF THE WASHOE COUNTY CODE BY CHANGING NAME OF SANITATION DIVISION TO UTILITY DIVISION.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 80.040 of the Washoe County Code is hereby amended to read as follows:

80.040 <u>Divisions of department of public works</u> enumerated.

The department of public works shall consist of:

1. The building and safety division.

- The engineering division.
- 3. The road division.
- 4. The utility division.
- 5. Such other divisions as the board of county commissioners may in its discretion from time to time establish pursuant to the provisions of NRS 244.151 et seq.
- SECTION 2. Section 80.080 of the Washoe County Code is hereby amended to read as follows:

80.080 Utility division: Appointment of chief

sanitary engineer.

- 1. The executive head of the utility division is the chief sanitary engineer, who shall be appointed by the board of county commissioners upon the recommendation of the county manager and director of public works.
- 2. The chief sanitary engineer serves at the pleasure of the board of county commissioners.
- 3. The chief sanitary engineer is responsible to the director of public works and has such powers and duties as are conferred upon him by the director of public works in administering the operations of the department.
