> BILL NO. 820 ORDINANCE NO. 647

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY EXPANDING THE BOUNDARIES OF CERTAIN DESIGNATED CONGESTED AREAS AND ESTABLISHING NEW CONGESTED AREAS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 50 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as sections 2to 7, inclusive, of this ordinance.

SECTION 2.

50.106 Incline Village: Congested area. The Incline Village area is determined to be a congested area and is specifically described as: All of sections 3, 8, 9, 10, 11, 14 and 15; all of sections 18, 19 and 30 bounded by the California-Nevada state boundary line and Lake Tahoe; all of sections 16, 17, 21, 22 and 23, 1.16 1.16R. 18 E., M.D.B.&M.

SECTION 3.

50.108 New Washoe City: Congested area. The New Washoe City area is determined to be a congested area and is specifically described as: All that portion of section 25, T. 17 N., R. 19 E., M.D.B.&M., lying easterly of East Lake Boulevard; all of sections 30, 31 and 32, T. 17 N., R. 20 E., M.D.B.&M.; all of sections 5 and 6, T. 16 N., R. 20 E., M.D.B.&M.

SECTION 4.

50.110 Old Washoe City: Congested area. The Old Washoe City area is determined to be a congested area and is specifically described as: The NW 1/4 of section 24 and all of section 23, T. 17 N., R. 20 E., M.D.B.&M.

SECTION 5.

50.112 Virginia Foothills-Steamboat-Pleasant Valley: Congested area. The Virginia Foothills-Steamboat-Pleasant Valley area is determined to be a congested area and is specifically described as: Beginning at the section corner common to sections 23, 24, 25 and 26, T. 18 N., R. 20 E., M.D.B.&M.; thence west to the westerly line of U.S. Highway 395; thence southerly and westerly along the

westerly line of U.S. Highway 395 to the intersection with the south line of section 5, T. 17 N., R. 20 E., M.D.B.&M.; thence west to the section corner common to sections 1 and 12, T. 17 N., R. 19 E., M.D.B.&M., and sections 6 and 7, T. 17 N., R. 20 E., M.D.B.&M.; thence south to the section corner common to sections 13 and 24, T. 17 N., R. 19 E., M.D.B.&M., and sections 18 and 19, T. 17 N., R. 20 E., M.D.B.&M.; thence east to the section corner common to sections 17, 18, 19 and 20, T. 17 N., R. 20 E., M.D.B.&M.; thence north to the quarter corner between sections 7 and 8, T. 17 N., R. 20 E., M.D.B.&M.; thence east to the center quarter corner of section 8; thence north to the quarter corner between sections 5 and 8, T. 17 N., R. 20 E., M.D.B.&M.; thence east to the section corner common to sections 4, 5, 8 and 9, T. 17 N., R. 20 E., M.D.B.&M.; thence south to the quarter corner between sections 8 and 9; thence east along the east-west centerline of section 9 to the quarter corner between sections 9 and 10, T. 17 N., R. 20 E., M.D.B.&M.; thence north to the section corner common to sections 3, 4, 9 and 10, T. 17 N., R. 20 E., M.D.B.&M.; thence east to the quarter corner between sections 3 and 10; thence north along the north-south centerline of section 3 to the quarter corner between section 3 and section 34, T. 18 N., R. 20 E., M.D.B.&M.; thence east to the section corner common to sections 1 and 2, T. 17 N., R. 20 E., M.D.B.&M., and sections 35 and 36, T. 18 N., R. 20 E., M.D.B.&M.; thence north to the section corner common to sections 23, 24, 25 and 26, T. 18 N., R. 20 E., M.D.B.&M., the point of ending.

SECTION 6.

50.114 Lockwood: Congested area. The Lockwood area is determined to be a congested area and is specifically described as follows: All of section 17, T. 19 N., R. 21 E., M.D.B.&M., which lies between the middle of the Truckee River and Interstate Highway 80.

SECTION 7.

50.116 Painted Rock: Congested area. The Painted Rock area is determined to be a congested area and is specifically described as follows: Those portions of sections 13, 14 and 23, T. 20 N., R. 23 E., and sections 7, 8, 9 17 and 18, T. 20 N., R. 24 E., M.D.B.&M., which lie between the middle of the Truckee River, Interstate Highway 80 and the Washoe-Storey County steel truss bridge in said section 23.

SECTION 8. The leadline, and not the body, of section 50.096 of the Washoe County Code is hereby amended to read as follows:

50.096 Greater Truckee Meadows and Environs: Congested area.

SECTION 9. Section 50.098 of the Washoe County Code is hereby amended to read as follows:

50.098 Callahan Ranch, Galena Terrace, Mountain Meadows, Galena Forest areas: Congested area. The Callahan Ranch, Galena Terrace, Mountain Meadows and Galena Forest areas are determined to be congested areas and are specifically described as: Beginning at the northeast corner of section 2; thence southerly along the line common to sections 1 and 2 and to 11 and 12 to the one quarter corner commmon to the said sections 11 and 12; thence westerly along the one quarter section line to the one quarter corner common to sections 10 and 11; thence southerly along the section line common to sections 10 and 11 to the section corner common to sections 10, 11, 14 and 15; thence westerly along the section line common to sections 10 and 15 and also common to sections 9 and 16 to the easterly line of the Mount Rose Highway; thence northerly along the said easterly line of the Highway to an intersection with the section line common to sections 4 and 9; thence easterly along the said section line common to sections 4 and 9 to the section corner common to sections 3, 4, 9 and 10; thence northerly along the section line common to the said sections 3 and 4 to an intersection with the north line of the south half (S 1/2) of the south half (S 1/2) of the said section 3; thence easterly along the said north line to an intersection with the section line common to sections 2 and 3; thence northerly along the said section line to the northwest corner of the said section 2; thence easterly along the north line of the said section 2 to the point of beginning, all sections above described being in T. 17 N., R. 19 E., M.D.B.&M.

- SECTION 10. The leadline, and not the body, of section 50.100 of the Washoe County Code is hereby amended to read as follows:
 - 50.100 Mustang area: Congested area.
- SECTION 11. The leadline, and not the body, of section 50.102 of the Washoe County code is hereby amended to read as follows:
 - 50.102 Wadsworth: Congested area.
- SECTION 12. The leadline, and not the body, of section 50.104 of the Washoe County code is hereby amended to read as follows:
 - 50.104 Spanish Springs area: Congested area.
- SECTION 13. Section 55.074 of the Washoe County Code is hereby amended to read as follows:
 - 55.074 <u>Callahan Ranch</u>, <u>Galena Terrace and Mountain Meadows area: Congested area.</u> The Callahan Ranch, <u>Galena Terrace and Mountain Meadows areas are determined</u>

to be congested areas and are specifically described as the N 1/2 of section 2, and the NE 1/4 of the SE 1/4 of section 2, T. 17 N., R. 19 E., M.D.B.&M.

SECTION 14. Section 55.080 of the Washoe County Code is hereby amended to read as follows:

55.080 <u>Incline Village: Congested area.</u> The Incline Village area is determined to be a congested area and is specifically described as: All of sections 3, 8, 9, 10, 11, 14 and 15; all of sections 18, 19 and 30 bounded by the California-Nevada state boundary line and Lake Tahoe; all of sections 16, 17, 21, 22 and 23, T. 16 N., R. 18 E., M.D.B.&M.

SECTION 15. Section 55.088 of the Washoe County Code is hereby amended to read as follows:

55.088 Spanish Springs area: Congested area. The Spanish Springs area is determined to be a congested area and is specifically described as: All of sections 23, 26, 27, 34, 35, 36 and the E 1/2 of sections 22 and 33, T. 21 N., R. 20 E., M.D.B.&M., and the E 1/2 of section 4 and all of section 3 west of the westerly right-of-way line of Highway 33, T. 20 N., R. 20 E., M.D.B.&M., and the W 1/2 of the SW 1/4 of the NW 1/4 and the W 1/2 of the NW 1/4 of the SW 1/4 of section 30, T. 21 N., R. 21 E., M.D.B.&M.

SECTION 16. Section 55.214 of the Washoe County Code is hereby amended to read as follows:

55.214 Spanish Springs area: Congested area. The Spanish Springs area is determined to be a congested area and is specifically described in section 55.088.
