ORDINANCE NO. 654

AN ORDINANCE AMENDING CHAPTER 25 OF THE WASHOE COUNTY CODE BY AMENDING SECTION 25.015, THEREBY CORRECTING A PRIOR INADVERTENT DELETION OF AN EXCEPTION TO BUSINESS LICENSE REQUIREMENTS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 25 of the Washoe County Code is hereby amended to read as follows:

25.015 License required for engaging in business; exceptions. Except as provided in this section, it is unlawful for any person to engage in any business, trade, calling, industry, occupation or profession in the county, outside of the limits of incorporated cities and towns in the county, without first procuring a license therefor from the county. No business license is required of those persons who provide care to 5 or 6 children in their homes pursuant to a valid license to conduct such activity issued by the Washoe County department of social services. The providing of child care in private homes to one child does not constitute engaging in a business, trade, calling, industry, occupation or profession.
