ORDINANCE NO. 728

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY DESIGNATING AREAS INCLUDING GALENA FOREST ESTATES AND SOUTHWEST PINES SUBDIVISIONS AS CONGESTED AREAS, THEREBY PROHIBITING THE RUNNING FREE OF DOGS WITHIN THAT AREA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Section 55.074 of the Washoe County Code is hereby amended to shall read as follows:

55.074 Callahan Ranch, Galena Terrace, Mountain Meadows, Galena Forest areas: Congested area. The Callahan Ranch, Galena Terrace, Mountain Meadows and Galena Forest areas are determined to be congested areas and are specifically described as: Beginning at the northeast corner of section 2; thence southerly along the line common to sections 1 and 2 and to 11 and 12 to the one quarter corner common to the said sections 11 and 12; thence westerly along the one quarter section line to the one quarter corner common to sections 10 and 11; thence southerly along the section line common to sections 10 and 11 to the section corner common to sections 10, 11, 14 and 15; thence westerly along the section line common to sections 10 and 15 and also common to sections 9 and 16 to the easterly line of the Mount Rose Highway; thence northerly along the said easterly line of the highway to an intersection with the section line common to sections 4 and 9; thence easterly along the said section line common to sections 4 and 9 to the section corner common to sections 3, 4, 9 and 10; thence northerly along the section line common to the said sections 3 and 4 to an intersection with the north line of the south half (S 1/2) of the south half (S 1/2) of the said section 3; thence easterly along the said north line to an intersection with the section line common to sections 2 and 3; thence northerly along the said section line to the northwest corner of the said section 2; thence easterly along the north line of the said section 2 to the point of beginning, all sections above described being in T. 17 N., R. 19 E., M.D.B.&M.
