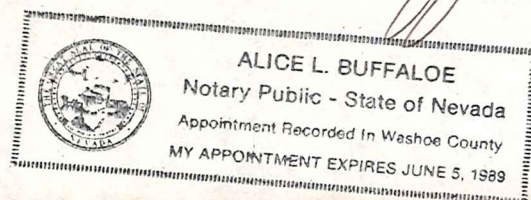

BILL NO. 917

ORDINANCE NO. 742

AN ORDINANCE ADDING TO THE BASIC POWERS GRANTED TO THE HORIZON HILLS GENERAL IMPROVEMENT DISTRICT THROUGH THE ADDITION OF THE BASIC POWER TO PROVIDE RECREATIONAL FACILITES; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The board of county commissioners of the County of Washoe does hereby grant to the board of trustees of the Horizon Hills General Improvement District the additional basic power to provide recreational facilities as more particularly described and as limited by NRS 318.143.


