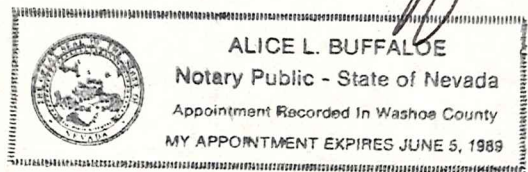

SUMMARY: Amends Washoe County Code by excluding cattle ranchers from prohibition against livestock running at large in congested areas of county.

BILL NO. 924

ORDINANCE NO. 749

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY EXEMPTING CATTLE RANCHERS FROM THE PROHIBITION AGAINST LIVESTOCK RUNNING AT LARGE IN CONGESTED AREAS OF THE COUNTY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Sections 55.184 of the Washoe County Code is hereby amended to read as follows:

55.184 Livestock trespassing or running at large unlawful; impoundment of livestock.

1. Except as provided in subsection 2, it is unlawful for any livestock, in congested areas of the county:

(a) To trespass on private property.

(b) To run at large on any public highway, street, alley, park, school or playground.

A violation of this subsection is committed by the owner or person having custody, control or possession of the livestock.

2. The provisions of subsection 1 do not apply to cattle owned by any person who is actively engaged in the raising and managing of cattle for sale in sufficient quantity to be capable of contributing materially to that person's support.

3. The animal control officer, his authorized representatives and peace officers, while on duty, may take up and impound such livestock and any other livestock which are endangering property, public safety, themselves or any other animal.




