AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CONSOLIDATING AND ENLARGING THE LOCKWOOD AND MUSTANG CONGESTED AREAS TO PROHIBIT THE DISCHARGE OF FIREARMS IN THE RAPIDLY URBANIZING AREA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 50.110 of the Washoe County Code is hereby amended to read as follows:

The following described area within the unincorporated area of the county is determined to be a congested area: All of sections 4 and 9, the West Half (W 1/2) of Section 10 lying northerly of Interstate Highway 80, the Northwest Quarter of the Northwest Quarter (NW 1/4 of the NW 1/4) of Section 15, the East Half (E 1/2) of Section 16 lying northerly of the middle of the Truckee River, the West Half (W 1/2) of Section 16 lying between Interstate Highway 80 and the middle of the Truckee River, and Section 17 lying between Interstate Highway 80 and the middle of the Truckee River; all of the above described parcels of land lying and being in T.19N., R.21E., M.D.B.&M.

SECTION 2. Section 50.114 of the Washoe County Code is hereby repealed.




