SUMMARY: Amends Washoe County Code by revising composition and terms of members of County Safety Committee.

BILL NO. 966

ORDINANCE NO. 791

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REVISING THE COMPOSITION AND THE TERMS OF MEMBERS OF THE COUNTY SAFETY COMMITTEE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 65.040 of the Washoe County Code is hereby amended to read as follows:

65.040 County safety committee: Composition, terms of office of members.

1. The county safety committee consists of eight members to be selected as follows:
  - (a) Two department heads, appointed by the board of county commissioners;
  - (b) One representative of the Washoe County Sheriff's Deputies Association, appointed by the association;
  - (c) One representative of the Washoe County Employees' Association, appointed by the association;
  - (d) The district health officer or his designated representative;
  - (e) The county safety officer;
  - (f) The county risk manager; and
  - (g) A director of a division of a county department, appointed by the county manager.
2. The term of office of each member of the county safety committee is as follows:
  - (a) The district health officer or his designated representative, the county safety officer and the county risk manager are permanent members;
  - (b) The two department heads, the representative from the sheriff's deputies association and the representative from the county employees' association are two year appointments;
  - (c) The director of a division of a county department is a one year appointment.
