

NOTICE IS HEREBY GIVEN that Bill No. 1093, Washoe County Ordinance No. 918. entitled,
AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REQUIRING CHILD CARE PROVIDERS FOR TWO OR MORE CHILDREN TO OBTAIN A LICENSE, MAKING A CHILD CARE LICENSE A REVOCABLE PRIVILEGE, REPEALING PROVISIONS RELATING TO REGISTERED CHILD CARE AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO WAS adopted on December 13, 1994, by Commissioners Steve Bradhurst, Dianne Corrnwall, Gene McDowell, and Jim Shaw. SUMMARY: Amends the Washoe County Code by revising provisions relating to child care.

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REQUIRING CHILD CARE PROVIDERS FOR TWO OR MORE CHILDREN TO OBTAIN A LICENSE, MAKING A CHILD CARE LICENSE A REVOCABLE PRIVILEGE, REPEALING PROVISIONS RELATING TO REGISTERED CHILD CARE AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 45 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

45.096 License for child care; license as privilege.

1. Any person desiring to provide child care in Washoe County must first obtain a license as provided by the regulations of the department.

- 2. A license issued pursuant to this chapter and the regulations of the department is a revocable privilege and no holder of such a license acquires thereby any vested right.
- <u>SECTION 2.</u> Section 45.010 of the Washoe County Code is hereby amended to read as follows:
 - 45.010 <u>Definitions</u>. As used in this chapter, unless the context otherwise requires:
 - 1. "Advisory board" means the board created by the county commissioners of Washoe County to advise the Washoe County department of social services.
 - 2. "Department" means the Washoe County department of social services.
 - 3. "Director" means the director of the department.
 - 4. "Child care" means child care for two or more children, if care for any of those children is for compensation.
 - 5. "HCAP" means health care assistance program.

- <u>SECTION 3.</u> Sections 45.045 of the Washoe County Code is hereby amended to read as follows:
 - 45.045 Regulations, guidelines and standards. The department may adopt regulations, guidelines and standards, and amend them as it may from time to time deem necessary in order to effectuate the provisions of this chapter. They shall be based upon the provisions of this ordinance, applicable local, state and federal laws, and the policies and standards as established and approved by the board of county commissioners.
- <u>SECTION 4.</u> Sections 45.095 of the Washoe County Code is hereby amended to read as follows:
 - 45.095 <u>Department designated as child care licensing agency.</u>
 - 1. The department is hereby designated as the child care licensing agency of Washoe County pursuant to subsection 1 of NRS 432A.131.
 - 2. Any person engaged in child care must be licensed as provided by this chapter and regulations adopted by the department.
- SECTION 5. Sections 45.100 of the Washoe County Code is hereby amended to read as follows:

45.100 Penalties.

- 1. Any person who provides child care in a center or home without possessing a valid license issued pursuant to this chapter and the regulations adopted by the department is guilty of a misdemeanor.
- 2. Any child care facility employee who provides child care for two or more children without possessing a valid temporary work permit or work permit authorizing him to do so is guilty of a misdemeanor.
- <u>SECTION 6.</u> Sections 45.105 of the Washoe County Code is hereby amended to read as follows:
 - 45.105 <u>Misdemeanor citation authority</u>. The department director and designees are hereby authorized to issue misdemeanor citations to violators of this chapter and the child care regulations.

SECTION 7. Sections 45.097 of the Washoe County Code is hereby repealed.
