SUMMARY: Amends Washoe County Code by adding a provision imposing a \$10 fee in civil actions in justice courts and district courts.

BILL NO. 1210

ORDINANCE NO. 1034

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ADDING THERETO PROVISIONS IMPOSING A \$10 FEE IN CIVIL ACTIONS IN JUSTICE COURTS AND DISTRICT COURTS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 20 of the Washoe county Code is hereby amended by adding thereto the provisions set forth as sections 2 through 4 of this ordinance.

SECTION 2.

20.775 Justice courts and district courts: Imposition of fee.

1. Pursuant to the authority granted in NRS 4.063 and NRS 19.0313, a fee of \$10 is hereby imposed for the programs of mediation in cases involving custody or visitation of a child and for a neighborhood justice center.

2. The fee imposed pursuant to subsection 1 must be paid on the commencement of any civil action or proceeding in the justice court and the district court for which a fee is required, and on the answer or appearance of any party in any such action or proceeding for which a fee is required.

3. The justice of the peace and clerk of the court shall credit \$5 of each fee to an account to be used for programs established pursuant to NRS 3.500 and the remaining \$5 of each fee to an account to be used for programs established pursuant to NRS 244.1607.

4. On or before the first Monday of each month, the justice of the peace and clerk of the court shall pay over to the county treasurer the separate accounts containing all fees collected by him pursuant to subsections 1 through 3.


