ORDINANCE NO. 1096

AN ORDINANCE AMENDING PROVISIONS RELATING TO WASHOE COUNTY CODE CHAPTER 110, ARTICLE 700, INFRASTRUCTURE AVAILABILITY AND FINANCING: TITLE AND CONTENTS AND ARTICLE 706, IMPACT FEES, BY AMENDING THE TITLE OF ARTICLE 706, IMPACT FEES TO DELETE THE REFERENCE TO A FUTURE ORDINANCE; AND TO AMEND ARTICLE 706, IMPACT FEES, BY CHANGING THE DEFINITION OF DEPARTMENT FROM THE DEPARTMENT OF COMMUNITY DEVELOPMENT TO THE DEPARTMENT OF WATER RESOURCES, AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Article 700, "Infrastructure Availability and Financing: Title and Contents" of Chapter 110 of the Washoe County Code is hereby amended as set forth in Exhibit A which is attached and incorporated by reference.

SECTION 2.

Article 706, "Impact Fees" of Chapter 110 of the Washoe County Code is hereby amended as set forth in Exhibit B which is attached and incorporated by reference.


